I acknowledge that I, all adults listed on our membership, my children, and all guests and invitees I bring, or allow to bring my children, to the Little Dipper Pool property, must abide by such policies and rules. I agree that I am responsible for monitoring and controlling my children and all guests and invitees I bring, or allow on to, the Little Dipper Pool property.
- 2. For myself, all adults listed on our membership, my children, and my guests or invitees to the Little Dipper Pool property, I acknowledge and agree to the following:
- Responsibility for Damages. - Waiver of Liability. Having assumed the risks stated hereinabove, for myself, for all adults listed on our membership, and for my children, I waive and forever release any and all claims, actions, causes of action, or other demands which I, the members signed below, or my children, have, now or in the future, against the Skyway Park Civic Association, its members, officers, board members, and employees, for death, drowning, injury to person or property, and for any other loss or damage suffered, resulting from swimming, swimming related activities, and any other activities engaged in on the Little Dipper Pool property.
- Agreement to Indemnify and Hold Harmless. Having waived certain liabilities above, I agree to indemnify and hold harmless the Skyway Park Civic Association, its member, officers, board members, and employees, from and against any liability incurred or suffered by the Skyway Park Civic Association, its members, officers, board members, and employees resulting from any use of the Little Dipper Pool property by myself, by all adults listed on our membership, by my children, and by any guest or invitee I bring, or I allow to bring my children, to the Little Dipper Pool property. Such obligation to indemnify and hold harmless means the obligation to fully reimburse any out-of-pocket loss suffered and to provide the costs of a reasonable attorney's fee to defend any such claims.
